## **Brief Synopsis of Thesis:**

From the perspective of urban political economy, we do research about the change in the identity of the municipalities Madrid's metropolitan periphery, in recent decades and especially in the era of globalization. That is, how is the change between being dependent outlying towns of the great metropolis to be central cities. This is maden by the empowerment of local identity strategies by local politics. The effects of such exaltation are reflected in the urban dynamics so that we can confirm the participation of certain social groups and the demobilization and exclusion from others. The thesis is an example of how identity strategies allow governance in globalized populations. The research is divided in two parts: one theoretical and the other applied. We use the cases of Alcobendas and Getafe to illustrate the thesis.

My current research centres around the inequality processes, urban segregation, urban/local identity, vulnerable groups, city marketing, urban regeneration processes, children in the city, sociology of tourism, food markets in the city, etc..
